Reports & Business

Curator - Bob reported that everything from the Welter family has been scanned. He also received some ads for cologne and tonic from around 1888 that were donated by Grace Becker.

Website - Steve was not present at the meeting, but he had some things to report. Sheldon reported in Steve's place, and reported that he has added more lines of biographical files to the new website. In all, there are about 2481 biographical files on the new website. Sheldon also reported that Steve had recently been at a meeting for the Wright County Historical Society on the 26^{th} of February. At the meeting, information was given on how to link our website with other historical society websites.

Interview Committee – The Interview Committee had only one thing to add, and that was that they were waiting for warmer weather to begin interviews.

Old Business – Bob reported on the progress with the Ken Zylla project. The painting is done and that it currently is in the process of having its colors separated. The painting should be printed in the very near future. John Jaeb is currently looking for a replacement treasurer. Lisa volunteered to take over John's duties as treasurer. Wayne motioned to make Lisa the new treasurer. Harry 2nded the motion. The motion carried for Lisa to become the new treasurer.

New Business – Discussion was made on some upcoming material for the next newsletter. Possible ideas for articles included something on the Ken Zylla painting, as well as an article on Ken himself. Another idea was of doing an article on the 30 year anniversary of when St. Michael was the subject for the Saturday edition of the Star Tribune's spot light. The new website was also brought up as an article possibility as well.

Adjournment – Bob motioned to end the meeting; Harvey seconded it. The motion carried. The meeting adjourned at 7:45 PM.
